## Additional Terms for TRF Loaner/Rental Neurofeedback Equipment Systems

In support of the TRF training courses, BEE Medic is committed to working out solutions for the provision of equipment worldwide.

Due to differing international conditions, we have a 'three territory' approach. The territory indicates whether we can provide you with a loaner or rental system.

In some countries, we have to consider individual solutions and may only be able to offer the purchase of the system. The following table shows the current possibilities for participating in a TRF training program and explains the conditions for the associated territory:

Territory	Conditions
Territory A	Free delivery of loaner equipment
Territory B	Delivery of rental systems at a cost is possible, but the freight charges must be covered. In some countries, a monthly fee must be paid, and/or a deposit will be requested. Before ordering or shipping, the conditions will be agreed upon mutually between BEEMedic and the course participant.
Territory C	Rental and loaner systems are not available in this country. The TRF Participant must purchase the system before the course starts. Deliveries will sometimes be subject to import duties or other fees. Before ordering or shipping, the conditions will be agreed upon mutually between BEEMedic and the course participant. In rare cases, we cannot supply the country at all.
